**Windsor Family Credit Union's (WFCU)
2015 Harold Hewitt Scholarship Recipients Announced**

On Tuesday, May 26 Windsor Family Credit Union (WFCU) announced the recipients of the 2015 Harold Hewitt Scholarship (HHS). Sixteen recipients were chosen, from over 330 submissions, to receive the special scholarship inspired by the late Harold Hewitt, WFCU's long term Director on its Board whose dedication to the community was an integral part of the credit union.

Earlier this year, youth enrolled in JK to Grade 12 were invited to respond to WFCU's question, "What does living in Windsor and Essex County mean to you and what do you appreciate about living here?" The successful recipients provided insightful responses and now share in a total of \$5,000 in scholarship funds.

The Harold Hewitt Scholarship program is one of WFCU's annual contributions to post-secondary education for youth in the Windsor-Essex community. Over the past 13 years, WFCU has presented 192 youth in the community with post-secondary school scholarships through the Harold Hewitt Scholarship program totaling \$75,900.

The Deposit Insurance Corporation of Ontario (DICO) is the provincial deposit insurer equivalent to the federal Canada Deposit Insurance Corporation. WFCU's financial and operational strength is a result of planned initiatives developed in order to ensure that it strives to be the best.

WFCU is a loyal and active member of Central 1, the credit union's banker, trade association, and a financial cooperative. Central 1's role is to serve as central financial facility, liquidity manager, payments processor and trade association for the provincial credit union systems of British Columbia and Ontario. It provides leadership, advocacy, technology, and a range of support services in fulfilment of these key functions. Central 1 holds \$12.9 billion in assets.
